



District Energy Benchmarking of Existing Buildings Covered Buildings List 2013

This list contains all the Privately-Owned Properties in the District of Columbia over 100,000 gross square feet that are covered by the District of Columbia's Energy Benchmarking Laws and Regulations (D.C. Code § 6-1451.03; 20 DCMR 3513). Please use this list to determine if your buildings need to submit benchmarking data to the District Department of the Environment (DDOE) by April 1, 2013. In 2014, the program will expand to include properties over 50,000 sq ft; a new list will be published at that time.

The following fields are listed for all properties: the Unique Building Identifier (UBI), the Gross Square Footage (GBA), the Premise Address, the Owner of Record or Condominium Name, and the Ward. This dataset is derived from the Computer Assisted Mass Appraisal (CAMA) database, the District's centralized real property database, maintained by the District's Office of Tax and Revenue (OTR) and Office of the Chief Technology Officer (OCTO).

This is the second version of this list DDOE had produced in 2013, using more complete data from OTR. Close to 200 additional properties have been added, and the gross building area for many properties has changed. DDOE apologizes for any confusion that may result.

Unique Building Identifier:

The UBI is the District Government ID for real property as determined by OTR. For most properties, this is the property's Square Suffix Lot (SSL) or Parcel number. For condominium buildings, this is the Square Suffix + Regime number (the regime number is a number assigned to every condominium upon incorporation). The number for your property should be entered in the Unique Building Identifier (UBI) field in ENERGY STAR® Portfolio Manager. If your property covers multiple parcels or tax lots (and is not a condominium), enter all included SSL/parcel numbers in the Unique Building Identifier field in Portfolio Manager.

Gross Building Area:

This is the total gross square footage recorded for your tax or parcel lot, or your condominium. Note that this number may *not* be the same as the building square footage you need to enter in ENERGY STAR Portfolio Manager. In many cases, the tax lot GBA numbers only count space above ground level. For condominiums, OTR does not track the size of common areas, so common areas are similarly not included. However, if you have basement, common area, garage, or other space that contributes to the energy use of your building, then you need to include that space when determining your square footage for benchmarking in Portfolio Manager.

Many tax lots have more than one building on the lot. Unfortunately, OTR does not track the size of individual buildings in such cases. Pursuant to DDOE's regulations, if your property has energy or water meters, or building systems (such as a central gas furnace), shared across multiple buildings without sub-metering, then the energy use cannot be attributed to any individual building. In such cases, the building must be benchmarked as a single building or campus in Portfolio Manager, and the square footage threshold for compliance with the benchmarking requirements is the total square footage of all buildings sharing systems.

If your building is in fact separately metered for all building systems, please contact DDOE at info.benchmark@dc.gov and explain your situation. Signed, supporting documentation will be required to demonstrate the gross floor area of the buildings, and that are separately metered for all utilities.

If you think the OTR listed square footage is in error *by a sufficient amount to affect when or if you have to comply* with the benchmarking regulations, please contact DDOE at info.benchmark@dc.gov and explain your situation. A re-appraisal of your property by OTR may be requested.

This list is provided by DDOE for the sole purpose of assisting the regulated community. However, inclusion on, or absence from, this list does not represent ultimate legal determination of whether a building is covered by the regulation. If you believe your building is over 100,000 gross square feet, you are still required to report by April 1, 2013, even if you do not see your building on this list.
